Volunteer “BIG” Waiver – Agreement and Release

This Voluntary Waiver, Assumption of Risk and Release Agreement (“Agreement”) is hereby executed by the undersigned (“Participant”) in favor and for the benefit of the Organizers (as defined herein). In connection with Participant’s involvement in any activity, conduct, or event which my relate to the Big Brothers Big Sisters, the Participant hereby certifies, warrants, represents, agrees and covenants to the Big Brothers Big Sisters, its officers, directors, employees, agents, representatives, affiliates, and assigns and any of the respective Event sponsors or promoters (individually and collectively, together with their respective affiliates, officers, employees, partners, shareholders, members, sponsors, contractors, agents, successors, and assigns the “Organizers” that he/she is:

Public Relations and Media Authorization

I hereby authorize Big Brothers Big Sisters to use photographs and/or stories about my participation as a BIG Brother and/or BIG Sister in the Big Brothers Big Sisters public relations and publicity program. Volunteer does hereby grant and convey unto Big Brothers Big Sisters all rights, title, and interest in any and all photographic images and video or audio recordings made by Big Brothers Big Sisters during the volunteer’s activities.

Medical Authorization

Volunteer does hereby release and forever discharge Big Brothers Big Sisters from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the volunteer’s activities with Big Brothers Big Sisters. This is to authorize the performance of necessary medical and/or surgical treatment for myself, _____ (Print Volunteer Name) in case of illness or accident. These medical services must be performed by a licensed medical doctor. I agree that Participant will be solely responsible for all physical injuries and that the participant agrees he/she derives a material benefit from the event and/or participant’s involvement therein, and that the event includes risks and hazards of injury to person and property.

Liability Waiver

By execution of this agreement, Participant expressly and unconditionally assumes all risks and dangers known or unknown, foreseen or unforeseen, and relating or incidental to participants involvement in the event and any activity associated therewith, whether caused by the negligence or conduct of the Organizers or otherwise. Participant hereby releases, forever discharges and holds harmless the Organizers from and against any and all claims, damages, liabilities, costs and expenses arising out of our relating to Participant’s involvement in the event and all activities associated there with. The undersigned does hereby release Big Brothers Big Sisters of all liability of any kind whatsoever during their volunteer participation conducted by or on behalf of Big Brothers Big Sister.
